PROCEEDINGS

In the proceedings first read above, orders were issued allowing 9% of Dearness Allowance to the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited with effect from 01.07.2018. In the Government Order second read above, orders were issued enhancing the rate of Dearness Allowance from 9% to 12%, payable to the Pensioners/Family Pensioners with effect from 1st January, 2019. It has been decided to extend the same benefit to the Pensioners/ Family Pensioners of TANGEDCO.

2. Accordingly, it is hereby ordered that the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited, be paid Dearness Allowance with effect from **1**st **January**, **2019** at the following rates:-

Date from which payable	Revised rate of Dearness Allowance (per month)
1 st January, 2019	12% of Basic Pension/Family Pension.

- 3. Consequently, the enhanced Dearness Allowance at the rate of 12% be paid along with the Pension/Family Pension for the month of **May 2019** and the arrears for the period from **1.1.2019 to 30.04.2019**, shall be paid to the Pensioners/Family Pensioners on **15.06.2019**.
- 4. The amount of Dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee, if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.
- 5. In the case of divisible family pension, the Dearness Allowance shall also be paid proportionately.
